At the March 18, 2010 board meeting the board approved a facility use permit with Phantom Fireworks and forward to the Board of Supervisors for final adoption. The facility use permit excluded Pokelma Park. District staff is recommending allowing Phantom Fireworks the exclusive right to operate a fireworks stand at Pokelma Park at the negotiated price of \$1,000 per stand or 10% of profits sales whichever is greater as agreed by both parties.
